Changes to the Final Rule in SECY-07-0162

1. On page 2, first paragraph, following the first sentence, add: “Similarly, the NRC Strategic Plan Fiscal Year 2004--Fiscal Year 2009 includes as an Effectiveness Strategy improving NRC regulation by adding needed requirements and eliminating unnecessary requirements.”
2. On page 2, second paragraph, change the first sentence to read “To reduce unnecessary regulatory burden To further this goal, the NRC issued ...”
3. On page 21, line 14, replace the *Response* with the following:

A change in this area would not affect the ability of licensees to implement dose averaging if the Commission were to decide to adopt this practice in the future. The revision does not remove the requirement to record and report the doses received by monitored workers rather it simply removes the requirement for each licensee to compile the exposure history of each worker as recorded on FORM 5s unless the worker is being authorized to receive a planned special exposure. Should another purpose develop (such as dose averaging) that would justify such data compilation, it would be as easy to do as for a planned special exposure, because the records would still be available.
