ANNETTE VIETTI- COOK: The Commission is being asked to act on a Memorandum and Order responding to a petition from the NRC Staff challenging the Construction Authorization Board's April 11, 2011, and June 9, 2011, case management orders, and seeking a stay of those orders. The Commission, with Chairman Jaczko concurring has voted to approve a Memorandum and Order which denies the Staff's petition, and denies the Staff's stay request as moot. Commissioner Apostolakis did not participate in this matter. Would Chairman Jaczko, Commissioners Svinicki, Magwood and Ostendorff please affirm your votes?

This amendment adds nonpower reactor (NPR) licensees to the scope of those subject to fingerprinting requirements for unescorted access.
